GENERAL RULES AND REGULATIONS

Dear Exhibitor

Welcome to the 2019 NEDBANK ESTON SHOW.

The following General information is necessary to ensure the success and smooth running of our show, and we will appreciate it if you respect these few basic conditions.

GENERAL INFORMATION

VENUE: Beaumont Eston Farmers Club

(On the R 603 - off N3 Camperdown turn off)

DATE: Saturday 24th & Sunday 25th August 2019

TIME: Saturday 24th August 2019: 09h00 - 17h00

Sunday 25th August 2019: 09h00 - 16h00

1. BOOKING OF STANDS:

Please note that the booking of stands is on a **first come first serve basis** and will only be **confirmed on receipt of payment**.

- **Bookings for 2019 will open on the 29th April 2019, any bookings made before this date will be deleted**
- **Invoice number will be provided on receipt of application.** Use this number in all communication to do with the show.
- Bookings are confirmed by receipt of payment, email deposit slip quoting invoice number to: bookings@theestonshow.co.za
- Last date for bookings is **1 August 2019. Payment details will be included in your invoice**
- **Stands not paid for one month from the date of booking will be cleared on the website and be available to any other prospective exhibitor.**

We recommend that you use Firefox or Chrome to complete your booking. If you are using Internet Explorer, please ensure that it is the latest version! Otherwise the booking will not complete

The last date for stand bookings is 1 August 2019.

Payments for stands must be made by 1 August 2019, except in the case of late booking. No payments will be accepted on the weekend of the show and no exhibitor will be allowed to setup if payment has not been received in full.

You need to bring all your requirements for your stand as **no chairs, tables etc. will be supplied.**

Cancellation of stand bookings must be placed in writing and e-mailed to the show secretary by **1 August 2019**. No refunds will be paid out for cancellations after this date. Late booking refunds are at the discretion of the show committee.

PLEASE NOTE:

*Vehicles, ATV's, Quads, motorbikes, Golf carts, ride-on mowers/tractors and any other form of transport will **NOT** be allowed to operate in the show grounds or walk ways during the show period. Only exceptions will be show officials and emergency vehicles – **breaking of this rule will result in expulsion of the exhibitor from the show grounds.***

2. BUILD UP OF EXHIBITION:

All stands are to be set up by 17h00 on Friday 23rd August 2019. The judging of stands will take place on the Saturday morning. Please make sure that a company representative is present to accept your delivery of tents or any equipment/vehicles.

3. BREAK UP OF EXHIBITION:

After 16h00 Sunday 25th August 2019.

Exhibitors are requested to clear the area of their stand and leave it in the condition in which they found it. No exhibitors will be permitted to breakdown their stand before the show officially closes

4. EXHIBITOR RULES:

N.B: Removal of exhibits during the show is strictly forbidden. Your entry binds you to be on Show for the full duration of the Show.

N.B.: No exhibitor will be allowed to enter their stand area until full payment has been received.

- **SELLING OF FOODSTUFFS:**

Selling of food by Exhibitors is NOT permitted.

- **CATERING/BAR FACILITIES:**

Food will be available at the main marquee from 08h00 to 09h30 each day of the show.

NO REFRESHMENTS (FOOD, ALCOHOL, SOFT DRINKS) are allowed to be brought onto the Club Grounds.

ALL DRINKS are to be purchased from the Eston Club.

No alcohol may be consumed outside of the designated drinking areas

BULK ORDERS for drinks and catering supplies are to be placed with **Eston Club** catering@estonclub.co.za before **Friday 16 August 2019** between **08h00 and 12h00**.

Orders paid for on collection will be subject to a discount. Orders NOT paid for on collection will be charged at FULL bar prices.

Orders for **ICE** (blocks or cubes) are to be placed before **Friday 16 August 2019 – Office hours 08h00 to 12h00**

All orders are to be collected from Main Show Bar on first day of Show between 08h00 and 09h00

5. ELECTRICITY/POWER POINTS:

There are power points allocated on specific areas of the show grounds, these are marked on the map. **Should you require power for your stand, please ensure you are located close to a power point and indicate this on your booking form.**

NB: Please bring your own extension cords and double adapters – none will be provided.

NO generators are permitted. Should your requirements be greater than standard supply, please notify us well in advance.

6. INSURANCE:

Exhibitors must please ensure that they have adequate cover for all exhibits and risks. The organizers, Nedbank and the Beaumont Eston Farmers Association are not liable for any loss or accidents, which may occur.

7. INDEMNITY

No claim whatsoever shall lie against the NEDBANK ESTON SHOW and the Beaumont Eston Farmers' Association (BEFA) arising out of the theft of, loss, or damage to the property of any person or association of persons on the premises falling under the control of, owned or leased by the NEDBANK ESTON SHOW and BEFA irrespective of the cause of such theft, loss or damage. The NEDBANK ESTON SHOW and BEFA are hereby indemnified against any and all claims at the instance of any person or association of persons, which may arise out of the theft, loss or damage aforementioned. All persons enter the premises of the NEDBANK ESTON SHOW and Beaumont Eston Farmers' Association on the condition that they do so at their own risk and no claim will lie against the NEDBANK ESTON SHOW or BEFA for any damage or loss suffered to their person or property whilst they are on the premises, arising out of any cause whatsoever.

8. FIRE REGULATIONS:

The grass area surrounding the Club can be very dry, therefore please take the necessary precautions to prevent fires. No Braai fires will be allowed on stands.

9. PARKING:

Kindly make use of the demarcated parking area; no vehicles will be allowed into the exhibit area after off loading.

10. SECURITY:

The organisers have arranged full security, day and night from 18h00 Thursday 22 August to 08h00 Monday 26 August 2019. Any extra security needed is for your own account. **Private stand security will only be permitted from the security company as specified by the Eston Show Organisers.** All valuables and movable accessories should be removed after hours, as the organisers cannot be held responsible for any losses.

11. TELEPHONE/CELL PHONE:

Cellular phone communication is good in the area.

12. STAND HOLDER IDENTIFICATION:

Stand holders will be issued with exhibitor tickets. Two (2) of these tickets will be issued per Craft / Popup market stand and four (4) per Bottom Field stand.

N.B. NO ADDITIONAL COMPLIMENTARY tickets will be issued. Additional complementary tickets may be purchased from the show secretary in advance

13. LEAFLETS AND FLYERS

If you wish to hand out **leaflets or flyers**, confirm with the Show Chairman about their contents before distribution. Neither the Gate Staff nor any other Show official will hand out such items.

14. SHOW INFORMATION TENT:

The Show information tent is situated near the main marquee. Should you have any problems or queries during the show please direct these to the Show Tent where the organisers will assist.

IMPORTANT NOTICE

Please note that due to Government Legislation (Government Gazette, 1 February 2008) the following may not be sold at the Show:

1. Projectile discharging devices that are designed to discharge by means of compressed gas, compressed air or a spring, electrically or manually and which to cause serious bodily injury if used to commit an assault, including but limited not to BB guns, air soft guns, bows and arrows, spear-guns, blowpipes and darts, hunting slings, slingshots and catapults;
2. Sword;
3. Bayonet;
4. Baton;
5. Spear or assegai;
6. Panga;
7. Cattle prod;
8. Flick knife;
9. Dagger;
10. Knuckle knife;
11. Trench knife;
12. Throwing blade;
13. Non-metal or ceramic knife;
14. Tonfa;
15. Throwing star;
16. Any knife other than knives mentioned above, the blade of which exceeds ten (10) centimeters; or
17. Any other article, which is not a firearm, and which is made or modified to be used:-
 - 17.1. to injure or disable a person;
 - 17.2. to cause a person to fear that someone will be injured or disabled by that use; or
 - 17.3. for attack or defense in the practice of a martial art sport, art or similar discipline.

Please note that we will not tolerate any flouting of these laws as it will reflect on us.

Anyone caught selling any of these products will be asked to vacate the Nedbank Eston Show grounds immediately.
